## Water/Sewer e-Billing Registration Form

The Village of Coxsackie is now offering a free water/sewer e-Billing option to customers with water/sewer billing accounts. With this service customers can opt out of receiving a paper bill through the mail and instead elect to receive a water/sewer bill notification via e-mail. We also allow the option to receive both e-bills along with the standard paper bill.

To get started, simply fill out and return the authorization form on the second page or email <a href="mailto:nbereznak@villageofcoxsackie.com">nbereznak@villageofcoxsackie.com</a> with your full name(s), address(s) and account number(s). Customers may sign up more than one water/sewer billing account for e-Billing.

Choosing to sign up for e-Billing will not affect the way you pay your water/sewer bills. Customers will continue to have the following options for payment: Cash, Check, Debit/Credit, Online Banking and EFT.
