Fire Training Schedule

- Hazmat 1ST Responders Refresher course will be held on February 20, 2018 at The Catskill Fire Station.
- 2. Vehicle Rescue- Operation Level starts on March 12, 2018 at the County Training Center.
- 3. Basic Exterior Firefighting Operations (BEFO) will be starting on March 13 at 6:30pm. The first night will be orientation. A chief or line officer needs to be present with their firefighters who are signed up for this course.
- 4. Rescue Tech Basic will start on April 3, 2018 at the Tannersville Fire Station.

Tower/Radio Update:

Both New Baltimore and High Hill are nearing completion. New Baltimore operational with low-band. Simulcast equipment has been placed in four of the seven sites.

We have made progress in frequency acquisition and are finalizing the channel plan.

The Department of Emergency Services has been meeting with various agencies to ensure the frequency plan meets their needs.

We are still waiting for delivery of radio equipment along with antennas for two tower locations. This equipment was ordered last year.

<u>Tyler/New World CAD Project</u>- During this past month Project Manager Neil Kellegher sent letters/emails out to all fire chiefs/ fire companies requesting forms to be filled out regarding your fire apparatus and equipment. Copy of the letter and forms are in your packet. **PLEASE THESE FORMS NEED TO BE RETURNED BY FEBRUARY 23, 2018!** We need this information as we are in the preparation period of starting to build our Tyler/New World CAD for Greene County 911 in the beginning of March.

High Hazard Train Fire Courses at the NYS Fire Academy:

The New York State Office of Fire Prevention and Control has put into service their live-fire derailment prop at the NYS Fire Academy in Montour Falls. The course that will utilize this prop, 'High Hazard Train Fires', will be running as an open enrollment program on the following dates in 2018:

06/21/2018 - 06/22/2018 06/23/2018 - 06/24/2018 08/16/2018 - 08/17/2018

The course description is as follows-

High Hazard Train Fires

This course will prepare students to respond to incidents involving High Hazard Flammable Train (HHFT), which transport a single ignitable liquid product such as crude oil or ethanol. Topics covered will include strategic (offensive vs. defensive) and tactical decision making, tank car recognition, water supply, Class B foam operations and the effective use of cooling streams. As the majority of the course will consist of outside skills evolutions, some including live fire, it is a physically demanding course and students must be prepared to work in the various environmental conditions appropriate for the season in which the course is being conducted.

Designed for: Fire service personnel

Course Length: 16 hours

Prerequisite: Firefighter I or equivalent. Signed Training Authorization Letter required.

Materials Fee: \$45

Course Number: 01-09-0113 Course Location(s): Academy

We are also able to host one additional course on 09/15/2018 - 09/16/2018. We would like to offer this set of dates to be utilized as a closed offering for one county. We would limit registration to this offering to just the one county. This would help facilitate relationship building and teamwork amongst responders likely to work together should their area experience a train derailment involving crude by rail or other ignitable liquids. This is a first-come-first-served offer for any county with a Class I railroad in their jurisdiction and who believes that they could provide 24 students for this offering. All academy fees would apply, including the \$25 registration fee, \$45 materials fee, and lodging/commuter fee. Contact myself via email if you would like to reserve this offering for your county.

Leadership Series

This series will allow students to explore a number of different topics. The "Firefighter Best Practices – A Model Program" will look at the "Recommended Best Practices for Fire Department Training Programs" issued by the NYS Office of Fire Prevention and Control and the NYS Department of Labor Public Employee Safety and Health Program, how this effects your training program, and how to implement these practices within your own fire department.
