# VILLAGE OF COXSACKIE HISTORIC PRESERVATION COMMISSION MINUTES OF JUNE 8, 2021

#### **PUBLIC HEARINGS**

## A. 12 Reed St.

At 6:00 PM Chairperson, Pat Maxwell opened the public hearing regarding the application from Sharon Mahota for roof work at 12 Reed Street. The application was reviewed at the May meeting and deemed sufficiently complete for purposes of scheduling tonight's public hearing. The contractor, Andrew Brandt, was on Zoom to answer any questions. There was no input from the public. At 6:15 Michael Rausch moved to close the public hearing. David Dorpfeld seconded and the motion was unanimously approved.

## B. D.M. Hamilton Firehouse

At 6:15 Pat Maxwell opened the public hearing regarding the application from Hugh Quigley for repair and repointing of the mortar joints and repainting the brick and wood trim at 47 Reed Street. The application was reviewed at the May meeting and deemed significantly complete for purposes of scheduling tonight's public hearing. There was no input from the public. At 6:30 Wendy Warren moved to close the public hearing. Diane Fausel seconded and the motion was unanimously approved.

## C. Dolan Block

At 6:30 PM Pat Maxwell opened the public hearing regarding the application for exterior painting and repair/restoration work of the storefronts at 22-34 South River Street. The application was reviewed at the May meeting and deemed significantly complete for purposes of scheduling tonight's public hearing.
